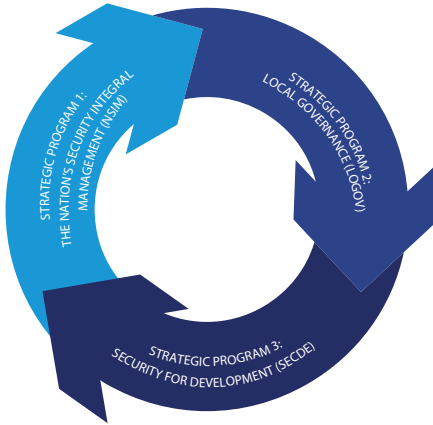


INTEGRATED GOVERNANCE STRATEGIC PROGRAMS



Strategic Program 1: Nation's Security Integral Management (GISEG)

Contributes to the strengthening of institutional capabilities of the National Security System agencies through the identification of needs and budgetary management.

Strategic Program 2: Local Governance (GOVLOC)

Encourages a multisectoral and multilevel approach to governance; it develops the capabilities of stakeholders at the local level through the implementation of mechanisms to capture citizen's needs.

Strategic Program 3: Security for Development (SECDE)

Develops effective mechanisms so that security would be complementary to the Government efforts, heightening greater interaction between economic productive activities and security.

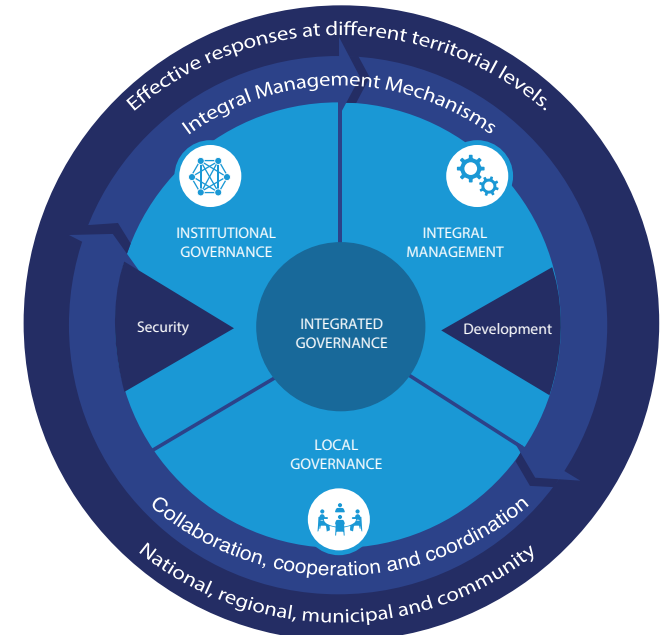

STRATEGIC GUIDELINES

- ▶ Align institutional policies and objectives to the National Security Policy.
- ▶ Promote the development and implementation of coordination, collaboration and cooperation mechanisms.
- ▶ Consolidate an effective police model.
- ▶ Promote interaction spaces for the development of coordination and alignment mechanisms between the functions of the security and defense forces.
- ▶ Strengthen dialogue spaces to establish alignment mechanisms between the diplomatic and defense functions.
- ▶ Develop and implement a National Intelligence Center to exercise command, control, computing, communication, and intelligence.

NATION'S SECURITY MODEL



- ▶ Consolidate the Public Service Career System.
- ▶ Foster the development of effective mechanisms of inter-institutional action for the structuring, call and mobilization of Civil Protection.
- ▶ Enhance inter-institutional mechanisms for the formulation of security needs in the sphere of local governance.
- ▶ Strengthen the inter-institutional coordination framework among the agencies related to security and development.
- ▶ Strengthen strategic alliances with key actors in society, universities, research centers, private sector, and others.
- ▶ Develop effective mechanisms for cyberspace protection.
